

WARRANTY

In this emissions limited warranty, the term "Manufacturer" means Polaris Industries Inc. (Polaris) as the holder of the U.S. Environmental Protection Agency (U.S. EPA) Certificate of Conformity for the vehicle. The Emissions Limited Warranty is in addition to the standard limited warranty for your vehicle.

Emissions Limited Warranty

The Manufacturer warrants that at the time it is first purchased, this emissions-certified vehicle is designed, built and equipped to conform with applicable U.S. Environmental Protection Agency (U.S. EPA) emission regulations for off-road recreational vehicles. The Manufacturer warrants that the vehicle is free from defects in materials and workmanship that would cause it to fail to meet these regulations.

The emissions warranty period for this emissions-certified vehicle starts on the date the vehicle is first purchased and continues for a period of 500 hours of engine operation, 5000 kilometers (3107 miles) of vehicle travel, or 30 calendar months from the date of purchase, whichever comes first.

This emissions limited warranty covers components whose failure increases the vehicle's regulated emissions, and it covers components of systems whose only purpose is to control regulated emissions. Repairing or replacing other components not covered by this warranty is the responsibility of the vehicle owner. This emissions limited warranty does not cover components whose failure does not increase the vehicle's regulated emissions.

For exhaust emissions, emission-related components include any parts related to engine control in the following systems: Air-induction system, Fuel system, Aftertreatment devices, Crankcase ventilation valves, Ignition system, Exhaust gas recirculation systems, Sensors and / or Electronic control units.

The following parts are considered emission-related components for evaporative emissions: Fuel Tank, Fuel Cap, Fuel Line, Fuel Line Fittings, Clamps*, Pressure Relief Valves*, Control Valves*, Control Solenoids*, Electronic Controls*, Vacuum Control Diaphragms*, Control Cables*, Control Linkages*, Purge Valves, Vapor Hoses, Liquid / Vapor Separator, Carbon Canister, Canister Mounting Brackets and / or Carburetor Purge Port Connector. (*As related to the evaporative emission control system.)

The exclusive remedy for breach of this limited warranty shall be, at the exclusive option of the Manufacturer, repair or replacement of any defective materials, components or products.

THE REMEDIES SET FORTH IN THIS LIMITED WARRANTY ARE THE ONLY REMEDIES AVAILABLE TO ANY PERSON FOR BREACH OF THIS WARRANTY. THE MANUFACTURER SHALL HAVE NO LIABILITY TO ANY PERSON FOR INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES OF ANY DESCRIPTION, WHETHER ARISING OUT OF EXPRESS OR IMPLIED WARRANTY OR ANY OTHER CONTRACT, NEGLIGENCE OR OTHER TORT OR OTHERWISE.

ALL IMPLIED WARRANTIES (INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE) ARE LIMITED IN DURATION TO THE WARRANTY PERIOD DESCRIBED HEREIN. THE MANUFACTURER DISCLAIMS ALL EXPRESS WARRANTIES NOT STATED IN THIS WARRANTY.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply if it is inconsistent with the controlling state law.

This limited warranty excludes failures not caused by a defect in material or workmanship. This limited warranty does not cover damage due to accidents, abuse or improper handling, maintenance or use. This limited warranty does not cover any vehicle that has been structurally altered, or when the vehicle has been used in racing competition. This limited warranty also does not cover physical damage, corrosion or defects caused by fire, explosions or other similar causes beyond the control of the Manufacturer. Owners are responsible for performing the scheduled maintenance identified in the manual(s) and instruction(s) included with the vehicle. The Manufacturer may deny warranty claims for failures that have been caused by improper maintenance or use, by accidents for which the Manufacturer has no responsibility, or by acts of God.

Any qualified repair shop or person may maintain, replace, or repair the emission control devices or systems on your vehicle. The Manufacturer recommends that you contact an authorized dealer or service center to perform any service that may be necessary for your vehicle. The Manufacturer also recommends that you use only Original Manufacturer parts. It is a potential violation of the Clean Air Act if a part supplied by an aftermarket parts manufacturer reduces the effectiveness of the vehicle's emission controls. Tampering with emission controls is prohibited by federal law.
